Kern and Boyle have meet with the contractor at the Parkway for the installation of the playground equipment. Weather permitted the Public Works department will get all the old playground equipment out by the end of March. The contractor said it will probably take 7-10 days to install the new equipment and hopefully the park will reopen sometime around Easter. As far as the Tot-Lot the equipment still needs to be ordered. If all goes we are hoping by October the Tot-Lot will also have new playground equipment installed. Mr. Kern has asked what the borough will be doing with the property at the fire department. President Bodish said there is no kitchen in the facilities and we are waiting for the committee to come back with suggestion on the facility.

Bodish- President Bodish stated that sanitation and streets is running under normal operations. Yard waste is on hold right now. The facility right now is asking the borough to separate each product grass, leaves and brush. The borough does not have man power to do this it would consist of three trips to the yard waste facility. The borough does need to offer yard waste to the resident per the Act 101 grant, stating if under 5,000 residents the service needs to apply. If we would not offer the service it could possibly result in loosing are grant money. We have called numerous places and unless you live in that township/borough there is no dumping for outside vendors. President Bodish spoke about ordinances and stated moving forward whoever is Chair of the committee would be responsible for this and then go to the office to follow up.
